Executive Council Report, April 2022

Tim Barney (for ECA's Rhetoric & Public Address Interest Group)

The Executive Council Meeting of the Eastern Communication Association took place on April 7, 2022. The meeting began with welcomes and introductions. The first order of business was the President's Report (Amanda G. McKendree), which revolved around strategies for the organization in a post-pandemic climate, and contemplating ECA's future. The problems of declining membership and lack of member engagement were discussed, and the President talked about different programs during the past year like the Professional Development Series and the War in Ukraine Listening Sessions.

Next, the Executive Director of ECA (Stacy Smulowitz) discussed more specifically the numbers of declining membership and interest group affiliations, particularly through the challenge of the pandemic. The numbers were at their lowest during July 2020, with the good news being that numbers have started to go up (albeit slowly) in the wake of the peak point of the pandemic. The Executive Director also discussed briefly the financial picture of ECA, with the full report inside the 2022 EC Annual Report Packet.

Pamela Lannutti (First Vice President) also offered a report as the chief planner of the 2022 Convention. The summary noted 355 total registrations, with 442 submissions, 118 total conference sessions, and 8 short courses.

Jennifer Waldeck (incoming First Vice President) offered a report about next year's conference (Baltimore from March 30-April 2, 2023), which has the theme of "Harboring Innovation." It was noted that the 2023 convention will take on many of the qualities of the canceled 2020 convention. The Report Packet notes the members of the new planning team and information about the Hyatt Regency, which is the home of the upcoming conference.

The Social and Digital Media Director (Rikishi Rey) discussed the innovation of the new convention app, as well as strategies to engage members over social media. The report also referenced the number of followers on platforms like Facebook, Twitter, and Instagram.

The next order of business was editor's reports from *Communication Quarterly* (Zac Johnson), *Qualitative Research Reports in Communication* (Inci Ozum Ucok-Sayrak) and *Communication Research Reports* (Keith Weber).

After each of the reports, discussion was opened around the upcoming sites for future conferences. The discussion then turned to an in-depth exploration of the controversy around whether ECA should or should not make statements about political and controversial issues. The Executive Committee leadership noted the influx of requests for the organization to weigh in on

a number of issues, most recently about the crisis/war in Ukraine. The crux of the contested discussion was the extent to which ECA should potentially have a committee that these requests for statements are forwarded to. The debate was also about how much political statements from professional organizations are largely ineffective and only symbolic. In addition, there was debate over whether these political statements are at least somewhat more productive if it truly involves the necessary expertise of members and leaders, and not just to make a statement for public relations' sake. It was agreed that this would continue to be a point of discussion.
